1. Student will be refunded full prepaid fee,
 - If student's enrolment is refused by ATMC
 - In an unlikely event where ATMC is unable to start the program
2. If student terminates enrolment before 14 days from the commencement, \$200 will be non-refundable.
3. In case student notifies cessation of studies less than 14 days prior to commencement, \$1,400 will be Non-Refundable.
4. In case student notifies cessation of studies after commencement but prior to completion of the first 10 weeks of the program, \$6,300 will be Non-Refundable. Required payment will be debited upon withdrawal, if student has opted for direct debit - monthly instalments.
5. In case student notifies cessation of studies after 10 weeks from the commencement, student is not entitled for any refund and student is liable to pay full fee/all remaining instalments. Required payment will be debited upon withdrawal, if student has opted for direct debit - monthly instalments.

TERMS AND CONDITIONS:

1. I understand that the professional year program consists of two face to face units (250 hours face to face); 1) Communication and Performance in the Australian Workplace 2) Entry and Advancement in the Australian Workplace, An internship (minimum of 240 hours of work experience, 20 hours for 12 weeks) which aims to provide an opportunity for the participants to develop professional skills specific to the Australian workplace and business environment, and a professional environments online subject provided by the ACS. I understand that no RPL is permitted within this program.
2. I understand that I need to have a valid visa throughout to undertake this professional year program. I acknowledge that I am wholly responsible for all matters concerning my visa and will not hold ATMC liable for any matters relating to this.
3. I understand that I may be refused enrolment if I am not meeting the admission criteria.
4. I understand that I am required to go through an interview before enrolment is formalised. I understand that ATMC reserves right to refuse enrolment if I fail the interview.
5. I understand that my enrolment letter will be cancelled automatically if my initial direct debit payment is declined.
6. I understand that any variation in the enrolment must be in writing and signed on behalf of ATMC.
7. I understand and acknowledge the refund policy mentioned in this Application and Enrolment Acceptance.
8. I understand that I will not be allowed to commence or continue course until all outstanding fees have been paid.
9. I understand that ATMC will debit required fee directly if relevant option is selected in this Application and Enrolment Acceptance. I understand that ATMC will count the direct debit dates from the commencement date.
10. I understand that I am required to have 100% attendance throughout the internship period and complete the work assigned.

14. I understand that I am expected to attend 100% of classes and must complete all of the assessments associated with the program. Any class absence due to illness must be supported by a valid medical certificate.

16. I understand that leave is not permitted during the program. In case of emergency, I must put a request in writing with supporting documents to the program coordinator and it will be assessed on case by case basis. I understand that leave approval may lead to delays in graduation.

I understand that if my behaviour is deemed unacceptable by ATMC, including but not limited to not following the student code of conduct or acts of plagiarism, my enrolment may be cancelled and I agree that I will not be entitled to a refund of any fee or other changes paid under these terms and conditions.

I understand that I will need to attend interviews for these positions; that Host Companies will be selected at the discretion of ATMC and that an offer of internship position is at the discretion of the Host Company.
